# **Announcements/Community Outlook:**

- > Joe Bosch (Clark):
  - O Joe expressed that in LaCenter where he lived there isn't much available for seniors except for Meals on Wheels. He contacted the Planning Commission, and they have a building that they would be willing to share for a senior center as long as there is a 501c attached. Joe is going to talk to some of the other community organizations to see if there are any that may want to help create a community center.
    - Mike would like to think about this some more to think about ways AAADSW may be able to help. He did extend the offer of support to Joe when attending meetings if it is needed in getting access to buildings or supportive services.
- Kathy Briggs (Wahkiakum):
  - o Kathy has an interest in digging more into what the obstacles are to getting the High School Home Care Aide classes into schools.
  - Kathy is also interested in looking into what it would take to get a community center in her area. She
    thinks that maybe reaching out to the community center in Longview to find out what they have and
    how they got it done would be a good starting place.
- Marianne Burkholder (Wahkiakum):
  - Shared that she and Kathy Briggs are collaborating on setting up discussions in the spring with the new Community Specialist Coordinator at Wahkiakum Health and Human Services to get to know her better. They want to check in to see what is being seen as needs for Wahkiakum seniors and to try and get some more social things started.

- > Pat Cano (Clark): Nothing to report.
- Diane Craft (Cowlitz):
  - Diane has been working behind the scenes to try and get good contacts willing to meet with Mike/AAADSW about the High School Home Care Aide program.
  - Diane has resumed meeting annually with all of her community partners. This is something that her agency had done pre-COVID and she is starting this practice up again. She is starting with the Skilled Nursing Facilities.
- > Arnie Dyer (Clark):
  - Weather dependent Arnie will be giving a presentation on 1/18/24 to the Three Creeks Rotary Club in Salmon Creek about the Clark County Men's Shed to hopefully recruit new members.
- > Jodi Oliver (Clark): Nothing to report.

#### **Guests:**

- > Shelley Baxter (Klickitat):
  - o KCSS still doesn't have a cook.
- Mary Repar (Skamania):
  - Mary advised that due to the freezing temperatures pipes burst at the Hegewald Community Center and things have been closed for 2 days.
  - Mary expressed that some of the current topics of interest to her are senior housing and rent control due to personal experiences.
  - Mary let the committee know that Skyline Hospital now has a skilled rehab center in White Salmon with about 10 beds.
- Kevin Callahan (Clark):
  - Kevin expressed interest in the work AAADSW is doing as well as Clark County Commission on Aging.
  - Kevin said that his background is in Government Services as a City Planner, Public Works Director and Emergency Management.
  - Kevin is interested in working together to try and address some of the challenges that seniors in the region are facing.

# Reports:

Executive Director's Report: Mike welcomed everyone and thanked our guests for joining us.

- High School Home Care Aide Updates:
  - o Gavin asked Mike what the awareness level is at the district level about this program. He is curious as to if there is a warm reception to the idea or not.
  - Mike said that he thinks it may be time to circle back around to those who he contacted in Wahkiakum County to see where things stand but he did have a very warm reception to the idea there.
    - Mike stated that in Wahkiakum County he had handed things to the person he was in contact with (Brent) and the person at the state level who works with this program.
    - Mike would like to set up a meeting to check in with the Wahkiakum County contacts to see where things stand and would like for Kathy to attend as a concerned citizen.
  - A barrier that Mike has heard expressed (especially in rural areas) is funding and funding of a
    position to teach the program.
    - Mike shared that he has shared his ideas on how to work around the funding issue (like having some of the classes offered virtually to a number of rural locations) with the state.

- Mike has support from the AAADSW board to offer some help in getting this program going.
   One-way AAADSW may be able to help is assisting in funding the salary of the position teaching some of the in-person/hands on requirements of the program.
- Clark County has something that is similar in the works. Cascadia Tech may offer the program over the summer.
- Kelso school district advised Mike that they have something similar, so they have said "thanks but no thanks" to this program.
- Mike hasn't had as much luck in getting meetings with people in the Longview School District and in Klickitat and Skamania counties. The last real big push Mike made was in the fall and he continues to reach out so that this doesn't get forgotten. He thinks that his best chance at success will be if he can get in front of the superintendents and discuss some of his ideas for overcoming barriers to try and gain traction for this program.
- Gavin advised that he will reach out to Mike offline to provide the contact information for Klickitat County.
- o In regard to support from AAA's for the High School Home Care Aide program, Mike is finding that AAADSW is the only one with a real interest in this idea. He said that the curriculum and program have already been vetted by OSPI (Office of Superintendent of Public Instruction) as well as the state so from a bureaucratic standpoint the two main monoliths are in place, supportive and in agreement on the curriculum, structure, etc.
- Snohomish County does have a program already up and running and the person at the state is directing interested parties to reach out to the school district to learn about how the program has been implemented.
- Diane has a Longview School Board member that she is working with who has requested a summary of the program and what AAADSW would like to do prior to meeting with Mike. (Mike will provide this).

#### Other:

- Mike shared that at the Federal level letters have gone out about sustaining the COVID-19 level of funding for senior services. This was the 2<sup>nd</sup> push advocacy wise for this to occur.
- Locally there were virtual meetings with 3 legislators where we were given verbal support for the two asks.
- There is still work going on getting more legislative meetings set up.
- Mike discussed a couple bills that have come to his attention but are not necessarily on AAADSW's radar.
  - House Bill 1702 and companion bill Senate Bill 5686
    - Act related to imposing a local sales tax of 0.01 percent of the selling price, in rural counties only, wholly credited against the state sales tax to support programs for senior citizens.

# Brainstorming on Advisory Council focus for 2024:

- o Do we want to continue with the "Getting to know you" time of the meetings?
- O Do we want to hold more time in the meetings for Advisory Council member's individual updates and report outs for more discussion time?
- Mary would like to discuss county designations. She voiced concerns that, based on the census, Skamania County is now not designated "very rural" like Klickitat is. The change in designation impacted needed funds and programs (like the Family Resource Center and the Veterans Van) in the county.
  - Gavin made the suggestion that Mary's topic would be a good topic of discussion for the Planning and Allocations committee.

- Mary also brought up the potential topic of suicide rates in rural counties for Advisory Council discussion in 2024.
- o Diane made a suggestion of the Advisory Council putting together a community guide of resources.
  - Mary stated that Skamania County has a resource guide available.
  - Christina advised that paper versions of resource guides are often not available now due to the constantly changing environment but resources are available online.
    - AAADSW ADRC has an online database that is used when they receive calls. The
      public facing site is:

    - AAADSW ADRC does have some paper resource lists available that are updated about once a year.
    - Christina also suggested 211 as they have online resources.
- Gavin suggested possibly doing training for new Advisory Council members around the services and resources that AAADSW has available as well as holding space for discussion in meetings about what resources in general are available.
- Christina will follow up with an email to get more ideas and then there can be a larger group discussion and finalization of topics at the February meeting.

#### Membership Vote:

#### Good of the order:

- Appreciation of outgoing Advisory Council Member Pearl Blackburn.
  - Gavin shared his thanks for Pearl Blackburn. Pearl's term on the AAADSW Advisory Council has been completed but she is still going to remain actively engaged in her community. Gavin shared that Pearl has been an Advisory Council member for 5 years (2018 – 2023) and that she has been a great advocate for Wahkiakum County. Gavin let Pearl know she is always welcome to join Advisory Council meetings as a guest when she has time.
  - o Arnie shared that he thinks of Pearl as the Wahkiakum County "unelected representative".
  - o Mike shared his gratitude for Pearl and expressed that he feels she has set the bar very high for Advisory Council members, particularly in Wahkiakum County. Pearl has been a voice for the seniors, especially the "West Enders" who often feel like they are left out. He thanks Pearl for carrying a big part of the Senior Heroes Awards (particularly in Wahkiakum County). Mike says that Pearl's impact will be lasting even after she is done with the Advisory Council.
  - Pearl let everyone know that she will continue to be active in the Advisory Council by "funneling" things through the other Wahkiakum members (Marianne and Kathy). She has invited the council members to stay in touch.
  - Colleen says Pearl "walks the walk" for senior engagement. She notices things and is very good at putting things together and matching needs with resources.
  - Christina says that she appreciates that Pearl is willing to roll up her sleeves to put in the work to get things done for her community. Christina shared about some of the larger projects that Pearl has given her time for like Senior Prom and working to get more resources for Wahkiakum County for the Senior Farmers Market nutrition youchers.
  - o Diane expressed that she hopes that Pearl will still head the bake sale in Cathlamet.
